Honorable Senator. Permit me please to compliment you on the boldness you are showing, and to say that you are proving yourself worthy of succeeding the Honorable. Sen. Bilbo.

As for F.F.C. and other anti South measures which the National Catholic Welfare Council is endeavoring to force upon you, let me tell you that if you will make the following statement on the 'floor' it will end it all. Just state - "If any of these anti South bills go through it will open the way for me to tell the truth about the cause of President Franklin D. Roosevelt's death -

Honorable Senator. These Catholic backers of the anti South bills cannot stand that exposure.

This is your anti dote. "It is hardly believable that a stroke of real apoplexy would take him so quickly that not even one pre death bad health bulletin would be given. Apoplexy?
