Dear Nathan:

This will thank you for your recent letter with reference to the serious problems our schools are facing.

The lack of concern of officials in Washington and the Federal courts in these situations is appalling. They seem to be much more interested in satisfying some vague, idealistic goal of a Federal, sociological bureaucrat, or someone else far removed from the problem, than they are in the education and welfare of our young people. I have been working against these irresponsible actions for many years but unfortunately thus far have not been extremely successful.

The only way we in the South will ever get relief from these punitive and disruptive demands of the Department of Health, Education, and Welfare and the Courts is by overwhelming public pressure from throughout the Nation to demand it. This pressure is beginning to develop because of court ordered and administrative actions against schools in the North and East. Hopefully this new push will result in the return of the administration of our schools to local and State Boards of Education where it belongs. Then and only then will there be a return to the primary purpose of our schools - the education of our young people.
